Subject: - Grant of Dearness Relief to State Government Pensioners/Family Pensioners-Revised rate effective from 01/01/2010.

In pursuance to the Ministry of Personnel, Public Grievances & Pensions, Govt. of India's OM No 42/18/2010-P&PW(G) dated 31st March 2010 on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to decide that the Dearness Relief (DR) payable to the State Government Pensioners/Family Pensioners shall be enhanced from the existing rate of 27% to 35% with effect from 01-01-2010.

All other terms and conditions as enunciated in Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioners Welfare, Govt. of India's aforesaid OM shall remain unchanged.
